GENERAL TERMS & CONDITIONS

1. Tender Opening Date & Procedure:

- The procurement shall be completed in accordance with Punjab Procurement Rules 2014.
- A single package of Technical and Financial Bids in complete conformity with Tender Documents will be dropped in Tender Box placed at Procurement Department of the GCUF, not later than **1200 Hrs on 06.12. 2016.**
- Bids will be opened on **06.12.2016 at 1230 Hrs** for evaluation by the "Printing Committee".

2. Tender Fee, Bid Security and Requirements:

- Bid must be accompanied by Tender Fee of Rs: 500/- in shape of Call Deposit Receipt (CDR) in original.
- Bid must be accompanied by Bid Security @ 2% of the estimated price of Rs.1,850,000/- (refundable) in shape of Call Deposit Receipt (CDR) in original.
- CDRs must be in favor of Treasurer, Government College University, Faisalabad.
- Bid must be accompanied with NTN and STN certificate of Firm.
- The rates / bids should be inclusive of all applicable Govt. Taxes.

3. Validity of Offers.

- Offers shall be valid for at least 180 days from the date of submission of bids.
- Withdrawal / modification of the original offer within the validity period shall entitle the University to forfeit Bid Security.

4. Failures and Terminations:

No offer of a supplier / firm will be considered if:-

- a) Bid received without Bid Security / Call Deposit or less CDR than the required.
- b) Bids received not in accordance with specifications of Tender Documents.
- c) Bid received later than the date and time fixed for tender.
- d) Bid is incomplete in any respect or is unsigned.
- e) Bid offer is ambiguous and the offer is conditional.
- f) Bid offer from a firm which is black listed at any level.
- g) Bids contain any erasing / cutting / overwriting etc.
- h) Successful bidder will be bound to provide standard & quality services.
- i) All Government Taxes will be deducted according to applicable rules

- j) If situation warranted, then University is authorized to forfeit the bid Security and the firm may also be black listed.
- k) The Firm fails to deliver the services as specified in accordance with the terms and conditions laid down in the Work Order.
- l) The decision of the Vice Chancellor of GC University, Faisalabad, would be final & binding on both the parties and not challengeable in any court of law.
- m) The GCUF reserve the right to reject all bids at any time prior to the acceptance of a bid, as provided under Rule-35 of Punjab Procurement Rules, 2014.

5. **OTHER TERMS AND CONDITIONS**

- i. The selected bidder has to ensure supply of the specified quantity, good quality of printing.
- ii. The selected bidder has to make arrangement for delivery at GCUF at his cost and responsibility.
- iii. The selected bidder will be held responsible for any untoward incidence occurred due to substandard/ bad supply and will be prosecuted as per law of the land.

6. **Technical verification**

The quality and quantity of printing shall be checked by the Coordinating Officials for the Convocation declared by the organizing committee for printing.
