1. INVITATION TO THE BID

Sealed Tenders are invited from reputed firms/Suppliers who are registered with Sales Tax and Income Tax Departments, for the provision of Consumable items for Semiconductor Physics and Renewable Energy Laboratory to be delivered at Government College University, Faisalabad.

2. INSTRUCTIONS TO THE BIDDERS

2.1 Tender Opening Date & Procedure:

The procurement shall be completed in accordance with Punjab Procurement Rules 2014, on **Single Stage - Two Envelope** Bidding Procedure.

Bids in complete conformity with Tender Documents will be dropped in the office of Principal Investigator, Department of Physics, Main Campus, G. C. University Faisalabad, not later than **11:00 Hrs on 10.06.2024** which shall be opened on the same day at **11:30 Hours**.

Note: Tender Number must be mentioned on the envelope.

2.2. Bidders must ensure that they submit all the required documents indicated in the Tender/Bid Documents at the time of opening of Technical Bids and no request for submission of missing documents will be entertained after opening of the Technical Bids.

2.3. Items will be purchased on FOR basis and payment will be made in Pak Rupees.

2.4. It will be clearly understood that the Terms and Conditions mentioned in this document are intended to be strictly enforced.

2.5. Bids without supporting documents, undertaking, valid documentary evidence, and bids not conforming to terms and conditions given in the Tender Document will be liable for rejection. Bids received after the due time and date & bids without Bid Security in shape of CDR or CDR less than required amount or Bid Security in shape of Cheque or Cross Cheque shall be rejected.

3 Tender Fee, Bid Security and Performance Security:

The Bid must be accompanied by Tender Fee of Rs: 1,000/- in shape of Call Deposit Receipt

(CDR) in original or bank deposit slip and Bid Security (refundable) of 2% of Estimated Price of “Rs 9,93,796/-” in shape of Call Deposit Receipt (CDR) in original. CDRs must be in favor of the Treasurer, Government College University Faisalabad. The rates/bids should be inclusive of all applicable Govt. Taxes. The 5% performance security applicable under the rules shall be deducted from the final bill of the successful bidder.

4 Validity of Offers:

- i. Offers shall be valid for 60 days from the date of submission of bids.
- ii. Withdrawal/modification of the original offer within the validity period shall entitle the University to forfeit Bid Security.
- iii. The Sales Tax Number and NTN must be mentioned on the letterhead and bidding documents.

5 Failures and Terminations:

No offer of a supplier/firm will be considered if: -

- 5.1 Bid received without Bid Security/Call Deposit or less CDR than the required.
- 5.2 Bids received not in accordance with specifications of Tender Documents.
- 5.3 Bid received later than the date and time fixed for tender.
- 5.4 Tender is incomplete in any respect or is unsigned.
- 5.5 The offer is ambiguous, and the offer is conditional.
- 5.6 Offer from a firm which is blacklisted at any level.
- 5.7 Any erasing/cutting/overwriting etc.
- 5.8 The supplier fails to deliver the consignment within the specified delivery period strictly in accordance with the terms and conditions as laid down in the Purchase Order.
- 5.9 Situation warranted, then University is authorized to forfeit the bid Security and the firm may also be blacklisted.

6 Other Special Conditions:

- 6.1 The decision of the Vice Chancellor of Government College University, Faisalabad, would be final & binding on both the parties.
- 6.2 Cheque or Cross Cheque shall not be accepted at all.
- 6.3 The amount submitted as Bid Security shall be refunded to the unsuccessful bidders after the decision for the award of the said tender.
- 6.4 The Bid Security of Successful Bidder(s) may be converted as part of the Performance Guarantee for successful execution of the work.
- 6.5 Subject to the delivery of goods against the Supply Order, the Bid Security in form of CDR shall be returned to vendor.
- 6.6 If the Bid Security is found to be less than the required amount, then the bid will be rejected irrespective of the rates and the stage of the bid process.
- 6.7 The Bid Security may be forfeited if a Bidder refuses to accept supply order of the Bid.
- 6.8 Firms having authorization letter from manufacturer of the requested equipment would be preferred.
- 6.10 Model number, country of origin and Company name must be mentioned on the bids.

Technical and Financial bid.

6.11 The technical brochure must be attached.

6.12 The 5% performance security applicable under the rules shall be deducted from the final bill of the successful bidder.

6.13 All Government Taxes will be deducted according to applicable rules.

6.14 The University may reject all bids/proposals at any time prior to the acceptance of a bid or proposal as per PPRA Punjab Rule 35, however upon bidder request the ground of rejection will be communicated to the concerned but no justification will be given as per PPRA rule 35 (2).

7. BID OPENING

7.1. Technical Proposal Opening

The bid's outer cover and Technical Proposal cover will be opened by the Purchase Committee of the project PAK-UK ICRG-2020 Reference No. 006327/D/ISB/008/2021, GC University Faisalabad on the date and time as specified in the Tender Notice /Bid Data Sheet. The bids will be opened in the presence of the bidders who choose to be present. A maximum of two representatives for each bidder would be allowed to attend the Bid Opening. Technical Specifications are given in Appendix A.

7.1.1 Suppression off acts and misleading information

During the bid evaluation, if any suppression or misrepresentation of information is brought to the notice of the Purchase Committee, the Committee shall have the right to reject the Bid and if it happens so after selection of the Bidder, the Purchase Committee may terminate the supply order or award of the supply order or further processing of the Bid as the case may be, and that will be without any compensation to the Bidder and the Bid Security/Performance Guarantee, as the case may be, shall be forfeited.

7.2 FINANCIAL PROPOSAL

7.2.1 The Financial Proposal of the bidder shall also include the price breakup of taxes/duties as given in Appendix B. All taxes/duties as applicable shall be responsibility of the bidders.

7.2.2. The cost quoted by the bidder shall be kept firm and unchanged for a period specified in the Bid/Tender Documents from the date of opening of the bids. The bidder shall keep the price firm/unchanged during the period of contract including during the period of extension of time if any.

The quoted price will be inclusive of all taxes, duties, levies, insurance, freight (transportation charges), etc.

7.2.3. For items to be imported on the name of University, Bidder will bear the Clearance and transportation Charges for delivery at site.

7.2.4. The Bid is liable for rejection if Financial Proposal contains conditional offer.
